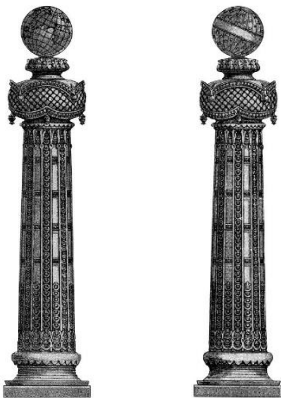

From the East:

Last month we were excited to welcome spring, hoping to get outside on warm sunny days. The lodge was busy with every Monday from the beginning of the year through April 13th having something scheduled. Plans were being made for community events that would help build relations with our neighborhood and our masonic family. Those plans have been put on hold starting March 13th, when the Most Worshipful Grand Master Ron Eggers declared a suspension of Masonic meetings through March 31, 2020.

While it may feel like an April Fool's Joke, the pandemic and the need for social distancing is quite serious. It is now likely that you know someone who has been exposed to this new strain of coronavirus (COVID-19). Along with the April Trestleboard, I am providing the Executive Order 20-12 of Governor Brown released on March 23rd and the Grand Master's April Edict released on March 27th. Of particular interest in the Executive Order, on page 4, section 2 is the listing of fraternal organization facilities as prohibited from operation. In accordance with this order and the Grand Master's Edict which extends the suspension of Lodge Meetings and Events to April 30th, there will be NO meetings at the Cornerstone Lodge Building, until such time the prohibition of them is lifted. Additionally, it has been agreed that Cornerstone Lodge will suspend the collection of monthly rent while our masonic family is unable to actually use the building. Individual representatives of each organization will be allowed on the premises for the purpose of collecting necessary materials for their continued business operations, but are asked to adhere to guidelines of the CDC and OHA with respect to disinfecting high touch surfaces such as doorknobs. Please be mindful that these recommendations are for your safety and the safety of others.

The degrees we had scheduled for March will be rescheduled as soon as we are permitted, and I urge all brothers to use this time we have been given to review the ritual, in an effort to minimize any delays. While we are unable to meet in person, we can still communicate by phone, text, email and the newly popular Zoom meeting. If there are any brothers in need of help, there are brothers who have volunteered to deliver groceries or handle other tasks that put susceptible individuals at risk. Please contact me for assistance, and I will coordinate with our volunteers.

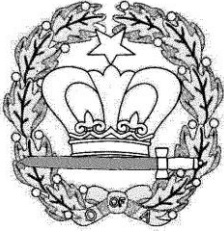
